Pursuant to the Regulation 30, 33 and other applicable regulations of SEBI (Listing Obligation and Disclosure Requirement) Regulations, 2015, we hereby inform you that the Board of Directors of the company in their meeting held today on Friday 14th November, 2025 have inter alia considered and approved the following matters: -

1. Approved the Un-Audited Financial Results of the company for the Second Quarter and Half Year Ended on 30th September, 2025 along with Limited Review Report. The statutory auditors have expressed an unmodified audit opinion on these results.
2. With reference to our earlier intimation dated November 06, 2025, we hereby inform you that pursuant to the Rights Issue and allotment of partly paid up Rights Equity Shares of the Company in the year 2024, the First, Second and Final Call Money was received for 48,12,910 equity shares out of 50,90,056 equity shares, which were converted into fully paid up Equity Shares of the Company. Thus, on total 2,77,146 partly paid up shares, the Company has not received the call money on time.

Further, the shareholders were intimated through various demand as well as reminder cum forfeiture notices requesting them to make the payment of outstanding call money within the due date / Final date vide First Call Money Notice dated August 24, 2024, First Reminder for First Call Notice dated December 04, 2024, Second Reminder for First Call Notice dated March 08, 2025 and Second and Final Call Money Notice dated May 15, 2025. The Company intimated to the shareholders in the notice and in the reminder notice(s) that non-payment of call money would attract forfeiture.

The receipt of First Call Money on 1,35,402 shares and the receipt of Second and Final Call Money on 1,41,744 shares still remained unpaid.

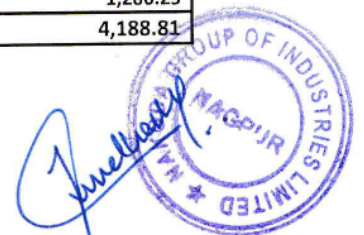

1. The figures for the corresponding previous period have been regrouped, reclassified and / or re-cast wherever necessary to make them comparable with the current period's presentation.
2. The financial results for all periods have been prepared in accordance with the Indian Accounting Standards ("Ind AS") notified under Section 133 of the Companies Act, 2013, read with the Companies (Indian Accounting Standards) Rules, 2015, as amended from time to time, and other recognized accounting principles and practices to the extent applicable.
3. The Company operates in a single reportable segment, i.e., Manufacturing and Trading of Dry Fruits, Tutti Fruity, and Other Agro Commodities. Accordingly, the disclosure requirements as prescribed under Indian Accounting Standard (Ind AS) 108 – "Operating Segments" are not applicable to the Company.
4. The Company does not have any Subsidiary, Associate, or Joint Venture. Accordingly, the requirements of Indian Accounting Standard (Ind AS) 110 – 'Consolidated Financial Statements' are not applicable to the Company.
5. The Company had issued 50,90,056, Equity shares of face value ₹ 10 each on a rights basis ("Right Equity Shares") to the eligible Equity shareholders at an issue price of ₹ 25 per share, including a premium of ₹ 15 per share. In accordance with the terms of the issue, ₹ 6.25 per Right Equity Share (i.e., 25% of the issue price) was received from the respective allottees at the time of application, upon which the shares were allotted. The Board of Directors decided to raise the balance amount through two further calls - a First Call of ₹ 8.75 per Right Equity Share (including a premium of ₹ 5.25 per share) and a Second and Final Call of ₹ 10 per Right Equity Share (including a premium of ₹ 6.00 per share). The Final Call was made on June 2, 2025. As at September 30, 2025, an aggregate amount of ₹ 15.82 Lakhs remains unpaid.
6. The above financial results were reviewed and recommended by the Audit Committee and subsequently approved by the Board of Directors at their respective meetings held on November 14, 2025. The Statutory Auditors have issued an unmodified report on these financial results.
7. As per the Regulation 46(2) of the SEBI (Listing Obligation and Disclosure Requirements), Regulation, 2015, the financial results are available of the Company's website; www.nakodas.com
